Please note for payments made by a CC, a 3% processing fee will be assessed to invoices per our credit card policy.

IMPORTERS/ CUSTOMS DUTIES, TAXES, EXAM, DEMMURAGE AND STORAGE FEES

Please note, credit limit granted does not extend to US Customs duties/taxes, exam fees, demurrage or storage advanced by Priority Worldwide.
All US Customs duties, taxes, exam fees, demurrage and storage are billed with COD terms (DUE UPON RECEIPT OF THE INVOICE).
Priority assesses a 3% advance fee on such disbursements prepaid on the importer's behalf. Alternatively, importers are encouraged to avoid the 3% disbursement fee assessed on US Customs duties/tax by joining the U.S. Customs and Border Protection Automated Clearinghouse Daily Statement Payment Program through which the importer pays their customs dues to US Customs directly. At your request, a prepopulated application for this program will be provided. Our licensed customs brokers will assist you in the application process. You will save money by paying your customs dues direct to customs through this program.
