- Generally, transact Customs business including filing of claims or protests under section 514 of the Tariff Act of 1930, or pursuant to other laws of the territory in which said grantor is or may be concerned or interested and which may properly be transacted or performed by an agent and attorney.

The grantor accepts that Air Cargo Transport Services Inc. dba Priority Worldwide Services will maintain records of all transactions for the prescribed time period according to the transaction type, and if requested, will provide the same to the grantor or any qualified recipient.
